Abstract

The present dissertation aims to analyse Victorian society and its reflection in the 19th-century novels such as *Hard Times* and *Oliver Twist* within the feminist framework. Discriminative attitudes in a patriarchal society and how females meet abuse from childhood are among the main concerns; therefore, these are also examined with a great emphasis and added to the research. Their miserable condition inspires the author of this study to shed light upon the women and children within their fictionalisation both in the Victorian novels and in different periods. Kate Millett's *Sexual Politics* is considered the secondary source to develop ideas and explain the quotes taken from the mentioned novels. Women and children have always faced discrimination, and the equality of the sexes has long been overlooked, particularly in patriarchal nations. Given that equality has not been entirely attained even now, Millett argues that the necessary equality may be attained with the right education. She also encourages women to respond to oppression in their own ways. Women may achieve equality by protesting against male domination and demanding what they are due.
